

## **CHAPTER 110: GENERAL LICENSING PROVISIONS**

### **§ 110.01 LICENSE REQUIRED.**

It is unlawful for any person, persons, firm or corporation to engage in any activity for which a license is required without first obtaining such license, as herein provided. The City Commissioners may at any time expand the general provisions of this title by requiring any person, persons, firm or corporation engaging in any trade, business, occupation or activity within the city which is not specified by this title to obtain a license, as deemed necessary.

### **§ 110.02 APPLICATION FOR LICENSE.**

Any person, persons, firm or corporation wishing to obtain a license as herein provided, shall make written application to Finance Officer stating the name of the applicant, address, purpose of the activity, the length of time for which the license is wanted, and the particular place at which the license is to be used. Fees for all licenses shall be fixed by the City Commissioners where not specified in this title and all license fees shall be paid in full at the time of application in such manner as approved by City Commissioners.

### **§ 110.03 LICENSE EXPIRATION.**

All annual licenses granted under the provisions of this chapter shall expire on the December 31 following the granting thereof, except as otherwise provided, and shall not be granted for any sum less than the annual rate, and there shall be no rebate made on the termination of the calling, vocation or kind of business for which the license was issued.

### **§ 110.04 DISCRIMINATION.**

All licensees shall conduct their business so as not to discriminate against any person because of race, color, sex, creed, religion, ancestry, national origin, familial status or disability.

### **§ 110.05 LICENSE REVOCATION.**

The Finance Officer has the authority at any time to suspend or revoke any license granted under the provision of this title whenever the City Commission shall be satisfied upon written complaint that such calling, vocation or kind of business for which the license was issued is in violation of the city ordinance, rule or regulation, or state law.

## General Licensing Provisions

### **§ 110.06 ISSUANCE.**

Except as otherwise provided, all licenses shall be issued by the Finance Officer and the applicant shall have complied with all requirements for issuance of such license. Unless otherwise provided, all licenses shall be signed by the Finance Officer and shall have affixed thereto the official seal of the city.

### **§ 110.07 RECORD OF LICENSES.**

The Finance Officer shall keep a record of all licenses issued by the City stating when and to who issued, for what purpose and for what length of time, the amount of money paid for the license, and the place where such activity is to be earned on.
