

## **CHAPTER 98: PARK USE REGULATIONS**

### **§ 98.01 TRESPASSING.**

No persons shall go on foot or otherwise on the grass or curb of any park or parkway when any prohibitory sign is posted. Absolutely no horses shall be allowed on the grass or curb of any park or parkway. It is unlawful for any person to ride a horse on any property other than his or her own.

### **§ 98.02 DESTRUCTION OF PARK PROPERTY PROHIBITED.**

No person shall injure or destroy any plant, shrub or tree in any park or parkway in the city.

### **§ 98.03 SIGNS PROHIBITED.**

No person shall post, paste, paint or fix any placards, bills, notices, or signs upon any structure or thing within any park, or upon any part of any park or parkway.

### **§ 98.04 EXHIBITIONS PROHIBITED.**

No entertainment or exhibition shall be given in any park or parkway, except those given under the direction and authority of the City Commission.

### **§ 98.05 DEFACING PROPERTY.**

No person shall injure or deface any building or structure within any city park.

### **§ 98.06 CLEANING UP LITTER AND REFUSE AFTER USE OF FACILITY.**

Any person, or group of persons, using any picnic areas, playground centers, or recreational facility and equipment belonging to and located upon park premises, shall be responsible for cleaning up litter and refuse, caused by their

occupancy, before leaving the area.

### **§ 98.07 METAL CONTAINERS, GLASS BOTTLES, GLASS CONTAINERS OR GLASSWARE PROHIBITED IN SWIMMING POOL AREAS OF PUBLIC PARKS.**

No metal containers, glass bottles, glass containers or glassware of any kind shall be taken by any person to any area of any public park that shall be designated by the City Commission as a swimming area.

### **§ 98.08 USE OF PARK WATERS.**

No person shall bathe, wade or swim in any park in the city; except at such time and in such place as may be specifically designated by the city. Notice of the time and place of the use of such waters shall be given by the city by appropriate signs posted in or on more conspicuous places in the park or around parks in which the waters are situated. The use of the waters situated in any park, except as permitted as to time and place by the city, is hereby forbidden. Each and every violation of any of the provisions of this section shall be considered a misdemeanor.

### **§ 98.99 PENALTY.**

Any person who shall violate any of the provisions of this chapter or any of the provisions of any resolution passed and published pursuant to this chapter, shall be guilty of a misdemeanor and shall be fined in an amount not to exceed \$500.
