PUBLIC HEARING – ORDINANCE TO AMEND CHAPTER 3.01 UR PERMITTED USES, CHAPTER 3.02 UR CONDITIONAL USES, CHAPTER 4.02 R CONDITIONAL USES, CHAPTER 19 DEFINITIONS; REPEAL & REINSTATE CHAPTER 11.15 BED & BREAKFAST ESTABLISHMENTS; & ADD CHAPTER 11.19 VACATION HOME ESTABLISHMENTS

## BUILDING PERMIT FOR SIGN AT JACK FOX PARK – OPEN AIR MARKET

Dan Heinemann spoke about the Open Market & that they are in their 3<sup>rd</sup> or 4<sup>th</sup> summer & that it runs from the 1<sup>st</sup> Thursday of June through the 2<sup>nd</sup> Thursday of August (approximately 10 weeks). They are looking to have something a little more permanent & they would construct the sign over the winter. Commissioner Leffler moved and Commissioner Iverson seconded to approve the placement of the sign & recommend approval to the City Commission. Motion carries.

#### DIALOGUE

Commissioner Iverson mentioned that a sidewalk still hasn't been put in at Dale Kroger's property at 326 South Broadway & that it's been several years since it should have been completed. AFO VanDeKieft advised that he was sent a letter again this month for him to advise of the status of the sidewalk being completed & that Dale did call to say that Heiskell Construction had completed a sidewalk permit with the City last year before giving him a quote & that they didn't end up getting the job. Dale had also indicated that he would put in the sidewalk if required but he asked about the process for appealing to not put a sidewalk in. Discussion ensued about him being aware from previous P&Z meetings that sidewalk is required.
